Description of works which is to be done for development of outer sides of playground of BRAIPRD (Gandhi Bhavan & Benoy Bhavan), Kalyani, Nadia by removing unwanted bushes, uprooting the weeds by earth-cutting manually / using Tractor, cleaning of the area, soil treatment by using chemical fertilizers and implanting new grasses.
