Norms of N.I.T No.01/2017-2018 dtd.22.09.2017:

- 1. The amount of security money of Rs.5,000/- (Rupees Five thousand) only for each **annexure** should be deposited by the 1st lowest, 2nd lowest & 3rd lowest Bidder, after the opening of financial Bid in form of draft infavour of The Director, BRAIPRD, Kalyani, West Bengal payable to SBI, Kalyani.
