b) the prospective outside bidders must have the credential of satisfactory completion as a prime agency during the last 5 (five) years from the date of issue of this Notice at least one work of similar nature having a magnitude of 40 (forty) percent of amount put to tender under authority of state govt./ central govt. State or central govt. undertaking statutory bodies constituted under the statue of the central /state government or equivalent as per order of the principal secretary to the govt. of West Bengal vide Ref. No. 04-A/PW/O/10C-02/14 dt. 18.03.2015.

N.B. : Completion certificate should contain a) name of work, b) name of client, c) amount put to tender, d) schedule month and year of commencement and completion as per work order, e) actual month and year of completion.

c) The prospective bidders must have valid upto date clearance of income tax return /profession tax clearance certificate/ PT (deposit challan)/ Pan card/ GST registration certificate/ Voter ID card for self identification and income tax acknowledgement receipt for latest assessment year.
